For many, the celebration of Veterans Day is anything but; the holiday pays tribute to all American veterans, living or dead.

The 11th hour, of the 11th day, of the 11th month signifies the end of World War l, occuring in 1918. From its first anniversary, November 11th was known as Armistice Day, and in 1938, it became a national holiday established by Congress. The

1950s brought many new changes, including the election of President Dwight D. Eisenhower. Under his leadership, the title of Armistice Day was retired and forth came Veterans Day, named to commemorate all personnel who have served the United States, whether in war or peacetime.

The Wauzeka-Steuben School District prides themselves on teaching their students on our history as a country, and to honor this, we hold a program each year with the entire school in attendance, and is always open to the community. Within the school, Hornet Council is an organization advised by Mr. Benjamin Dums. Hornet Council allows students an opportunity to develop leadership by organizing and carrying out school activities, and they are also representatives of the student body. As a highly-regarded club, they plan the Veterans' Day program to honor those who have served, and those who are currently serving.

This year, our program was held on November 12th. There were K-12 musical selections under the direction of Ms. Stephanie Cooper and Mr. Phil Stiemke; poems read by Badger State Representatives Nathaniel Benish, Lindsey Lund, Gabriel Martin, and Jenna McCarthy; other orators include Erin Krachey and Ravyn Krachey, Hornet Council Representatives, and guest speaker Mr. Erich Schmitt, U.S. Army Recruiter. SFC Schmitt has served for more than 15 years with four combat deployments, three to Iraq and one to Afghanistan. He has been stationed in Louisiana, Kansas, Texas, Alaska, Germany, and is currently in Onalaska. Mr. Schmitt's speech didn't solely focus on personal stories, though they were shared.

The scholarship is intended to be one of the premiere WSHS scholarships awarded to a graduating senior, with a current stipend level of \$2,000 payable near the time of the 1st semester college enrollment. Selection is based primarily on high school GPA, active participation in WSHS extracurricular activities, and college standardized admission tests such as ACT or SAT, thereby demonstrating considerable promise for academic success in college.

In order to provide long-term financial stability for the Alumni Scholarship, an endowment fund with a goal of \$50,000 is being set up. Any WSHS alumni or benefactor donation up to a cumulative level of \$25,000 will be matched dollar for dollar by the 1976 alumnus. All WSHS alumni and friends are encouraged to consider making a donation to help achieve the endowment goal for this scholarship.




