# BACK TO THE FUTURE FOR THE WAUZEKA-STEUBEN SCHOOL DISTRICT

Greetings, and I wish each of you my best as we enter a new year - 2019. Our school district has much to be proud of, and, at the same time, we face some tremendous challenges over the next few years. As I have said repeatedly since I arrived last January 2018, I am very impressed with the work our staff and students, and continue to enjoy interacting with and observing our students work and perform in the classroom and in their athletic, music, and other activities. Four "big picture" items that will require a great deal of our attention in coming months and years include: *Selection of a new district administrator, setting a vision for the school in our community, sustaining and building on school programming (academic & career prep) and developing and implementing an action plan for economic/community development.* 



- As an interim here in Wauzeka-Steuben Schools, I have seen the passion exhibited by students, staff, the board, and community members for our school. As in most small communities, the school is the hub of activity and a source of pride. Good, stable leadership is important. The next district administrator will need to work closely with the board and community to craft a clear vision for the school district. What do we want the district to look like 5 years from now? How about 10 years from now, or longer? In preparation for district administrator interviews and recruitment of candidates that began last spring and lasted throughout the summer, it was determined that the preference is for a part-time district administrator position that could be combined with another leadership position in the district.
- The school board and district administrator will need to deliver a clear vision for the school in our community. Is the district moving in a positive direction? What do we want the district to look like in the future? What do we want our school district to be "known for"? Answering these questions would determine how we differentiate (in a positive way) our school from others in the area and state. This vision should be compelling enough that it generates interest and energy stands on its own to attract and retain families in the community and school.
- Today more than ever, school programming (e.g., classes and curriculum) are critical. Students need to have educational experiences and coursework that will support their future in workplaces and beyond. We need to continue to develop programs that are good for our students, academic and career preparation, and that are competitive with other school districts. When referring to school programming, we need to give thoughtful attention to **ALL** programs academic & career prep, the arts, physical education, special education, etc.
- In order to attract and retain families to the Wauzeka community and students to the school, the district needs to work together with organizations like the Driftless Economic Development Inc., and business partners. For example, is there a pathway to developing affordable residential housing for families who may want to live here *for the school*, even if they commute to work in other surrounding communities? Is there business interest in supporting programming and other needs of the district (e.g., operations, or facilities)?

The future of the Wauzeka-Steuben School District will not be determined by test scores or state mandates. Rather, the will of the community will prevail in determining if there is support for working together collaboratively – staff, community, business – to not only sustain, but grow the Wauzeka-Steuben School by determining and moving forward a vision for students and community. Let the work begin! *- Dr. Gary Albrecht*



Many of the alumni from Wauzeka-Steuben High School have leveraged their WSHS education to become successful employees, entrepreneurs, and community leaders. The recently established Alumni Scholarship was initiated by a 1976 WSHS alumnus, and is intended to encourage academic excellence and additional post-high school education by helping defer tuition and related educational expenses at a four-year college for an outstanding graduating WSHS senior. The scholarship is intended to be one of the premiere WSHS scholarships awarded to a graduating senior, with a current stipend level of \$2,000 payable near the time of the 1<sup>st</sup> semester college enrollment. Selection is based primarily on high school GPA, active participation in WSHS extracurricular activities, and college standardized admission tests such as ACT or SAT, thereby demonstrating considerable promise for academic success in college.

In order to provide long-term financial stability for the Alumni Scholarship, an endowment fund with a goal of \$50,000 is being set up. Any WSHS alumni or benefactor donation up to a cumulative level of \$25,000 will be matched dollar for dollar by the 1976 alumnus.
